## NOTICE TO TRADESITE EXHIBITORS **SHOW DATE: 8 JUNE 2024**

Your Application for a Show Site is at the sole discretion of the Committee and is subject to the compliance by you with the conditions listed below.

1. All Site application forms must be lodged by 26th May.
2. All Site Holders report to Office before setting up site. Site allocations will be available for setting up from Friday the 9th June or earlier with prior arrangements.
3. Site fees need to be paid to the Treasurer by 3pm Friday or prior arrangements need to be made. Tax Invoices will be issued, on full payment of site.
4. The site fee includes 2 (two) passes for the duration of the show. Please ensure you collect these passes from the Secretary's office upon arrival.
5. Each Stallholder **MUST** carry public liability policy. A copy of the policy **MUST** be sent to the Secretary, with your application.
6. Your co-operation is sought in reporting to the Show Secretary any situation you may consider a potential hazard or danger to public safety.
7. Any site serving food or beverages must meet with the local Council Health by-laws. A copy of the by-laws can be obtained from the Show Secretary.
8. No items on the agreement list of banned items with the Showman's Guild are to be sold on the Showgrounds. Failure to comply will mean closure of your site with **NO** refund.
9. All sites must include full length of vehicle (no overhanging of "A" frames into next site).
10. All walkways must be kept clear.
11. The site fee covers camping at the Showgrounds from Friday to Sunday inclusive. Regular Winton Shire Council camping fees apply outside of these dates.
